| <p>The undersigned (the "Applicant") hereby applies for membership in and agrees to purchase electric service from NAVOPACHE ELECTRIC COOPERATIVE, INC., (the "Cooperative") under the following terms and conditions.</p> <ol style="list-style-type: none"> The Applicant will pay to the Cooperative the sum of \$5.00, which, if this Applicant is accepted by the Cooperative, will constitute the Applicant's Membership Fee. The Applicant will comply with and be bound by the provisions of the Articles, Bylaws and Policies of the Cooperative, as amended or supplemented from time to time, including those set forth in the Policy Manual, as well as such rules, regulations, and tariffs as may from time to time be adopted by the applicable Regulatory Commission. The Applicant, by paying a membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that his private property cannot be attached for any such debts or liabilities. By applying for membership and electric service, the Applicant hereby grants the Cooperative the perpetual right across, over, under or through the property for which service is requested to run service (including service lift poles, lines and appurtenances), to cut and trim trees and shrubbery, to read meters and to remove, extend, operate, maintain, replace, add to and repair Cooperative facilities as deemed necessary by the Cooperative in the ordinary course of business, and for ingress and egress related thereto. This grant applies to any subsequent services the Applicant obtains and is in addition to any other grant provided by the Applicant, its predecessors or successors. The Applicant is responsible for clearing of all utility rights-of-ways required for the benefit of the Applicant prior to construction of a power line by the Cooperative to serve the Applicant. The Cooperative at its option may clear the right of way and add the cost thereof to the total construction costs to be paid by Applicant. Where the Applicant performs the clearing, all the Cooperative's specifications shall be met and the Applicant assumes full responsibility for damage incurred during the clearing work or in the event of recall work. <p>The undersigned, having read this document in its entirety, warrants that all the information is true, correct and complete and that I have authority to execute it and perform all acts stated herein.</p> | |
